By signing below, I acknowledge that I understand that I must comply with all local, State and Federal laws at all times. While a partial list of relevant laws are listed below, I understand that it is my responsibility to comply with all law at all times.

Section 16-17-680(C)(1) states that anyone who wants to transport or sell nonferrous metals to a secondary metals recycler must have a permit issued by the Sheriff or meet certain specific exemptions.

Section 16-17-680(D)(1) makes it illegal to obtain a permit for the purposes of transporting or selling stolen or illegally obtained nonferrous metals.

Section 16-17-680 (E)(2)(a) provides that it is unlawful to sell nonferrous metals to a secondary metals recycler without this permit and for the secondary metals recycler to purchase such metals without the seller having this permit. The secondary metal recycler must have a permit to purchase such metals.

Section 16-11-523(B) makes it illegal to unlawfully damage any real or personal property in an effort to obtain any nonferrous metal.

2. PROPER VEHICLE INFORMATION (VEHICLE REGISTRATION)
 - B. THIS INFORMATION MUST BE CURRENT.
