**AN ORDINANCE TO AMEND ORDINANCE NO. 18-04 (DARLINGTON COUNTY FY18/19 BUDGET ORDINANCE) FOR A SUPPLEMENTAL APPROPRIATION TO THE LIBRARY FUND TO RECEIVE AND EXPEND STATE LIBRARY GRANT FUNDS FOR DARLINGTON COUNTY LIBRARY SYSTEM AND ESTABLISH THE EFFECTIVE DATE OF THIS ORDINANCE**

**PURPOSE:**

The purpose of this ordinance is to supplement the county's FY18/19 Budget Ordinance (Ordinance No. 18-04) for Darlington County Library System to receive and expend \$10,410 in State Library Grant funds to move forward with its "Imagine the Possibilities as a 3D Designer Project.

**NOW, THEREFORE BE IT ORDAINED, by the governing body of the County of Darlington, South Carolina, the Darlington County Council, that:**

**SECTION I.**

Section 1 of Ordinance No. 18-04 is hereby amended to receive and expend the following funds:


