## **Boards/Commissions**

**Accommodations Tax Advisory Committee:** provides recommendation for the allocation of Accommodations Tax funds. Weekly meetings during March/April.

**Alcohol & Drug Citizen Advisory Committee:** provides citizen input into the development & implementation of the county alcohol and drug abuse plan. Meeting dates vary.

**Ambulance Commission:**{ resident} prescribes rules and regulations governing the ambulance service district. Meet every other month.

**Assessment Of Appeals Board:** hears appeals regarding valuation and assessments placed upon property. Meet as needed.

**Construction Board of Adjustment & Appeals:** hears appeals of decisions/interpretations of the building official. Meet as needed.

**Economic Development Partnership Board:** works to improve the economy of the county through the acquisition and development of new industry, the expansion of existing industries, and the retention of industry. Quarterly meetings.

**Fire Control Board:** {resident of the district & volunteer firefighter} formulates recommendations to strengthen, promote, coordinate, & improve fire protection services within the district. Monthly meetings.

**Historical Commission:** works to gather, maintain, & preserve historical records & artifacts of the County. Monthly meetings.

**Jetport Commission:** provides advisement on matters affecting aeronautics, the operation of the County's Jetport & it facilities, and compliance with state & federal regulations. Monthly meetings.

**Library Board:** exercises powers/regulations to establish/equip/operate/maintain an effective library system. Monthly meetings.

**Parks & Recreation Commission:** formulates recommendations to govern, strengthen, and promote recreation programs. Quarterly meetings.

**Planning Commission:** undertakes a continuing planning program for the physical, social, and economic growth, development, & redevelopment of the unincorporated areas of the county. Monthly meetings.

**Pee Dee Workforce Investment Board:** works with members appointed from other Pee Dee counties representing business, labor, education, and community organizations to create a world-class workforce development system in the Pee Dee Area. Meeting dates vary.

**Pee Dee Regional EMS:** Council appoints one member. This Board promotes educational resources for emergency medical service related courses, etc.

**Pee Dee Regional Transportation Authority (PDRTA) Board:** Council appoints one member. This Board governs the operation of PDRTA.

**Pee Dee Resource Conservation & Development Area Council:** Council appoints one member. This Board helps people care for & protect their natural resources in a way that improves the local economy, environment & living standards.
