# COUNTY COUNCIL APPOINTED BOARDS / COMMISSIONS / COMMITTEES

## GENERAL DESCRIPTION

[Accommodations Tax Advisory Committee](#) - reviews applications and provides funding recommendations for the allocation of Accommodations Tax funds. Meets 1 to 2 times during March/April at 6 p.m. in Darlington.

[Airport Commission](#) - provides advisement on matters affecting aeronautics, the operation of the County Airport & its facilities, and compliance with state & federal regulations. Meets on the 3<sup>rd</sup> Thursday at 8:30 a.m. in January, April, August, & November at the Airport.

[Alcohol & Drug Citizen Advisory Committee](#) - provides citizen input into the development & implementation of the county alcohol and drug abuse plan. Meets on the 4<sup>th</sup> Thursday in January, March, April, May, October, & December at 3 p.m. in Hartsville.

[Board Of Assessment Appeals](#) - hears appeals regarding valuation and assessments placed upon property. Meets as needed.

[Board Of Fire Control](#) - formulates recommendations to strengthen, promote, coordinate, & improve fire protection services within the district. Must be a resident of the district & a volunteer firefighter. Meets on the 2<sup>nd</sup> Thursday of every other month at 7 p.m. in Darlington.

[Construction Board of Adjustment & Appeals](#) - hears appeals of decisions/interpretations of the building official. Meets as needed.

[Economic Development Partnership Board](#) - Performs the functions of planning, developing, maintaining, equipping, advising, benchmarking, & evaluating the county's economic development programs and activities. Meets quarterly on the 3<sup>rd</sup> Wednesday at 8:30 a.m.

[Historical Commission](#) - gather, maintain, and preserve historical records and artifacts of Darlington County. Meets monthly on the 1<sup>st</sup> Thursday at 10 a.m. in Darlington.

[Library Board](#) - exercises powers/regulations to establish, equip, operate, & maintain an effective library system. Meets on the 3<sup>rd</sup> Wednesday of every other month at 5 p.m.

[Parks & Recreation Commission](#) - formulates recommendations to govern, strengthen, and promote recreation programs. Meets every other month on the 2<sup>nd</sup> Tuesday at 6 p.m. in Darlington.

[Planning Commission](#) - undertakes a continuing planning program for the physical, social, and economic growth, development, & redevelopment of the unincorporated areas of the county. Meets monthly on the 3<sup>rd</sup> Wednesday at 4 p.m. in Darlington.
