

**ORDINANCE NO. 24-12**

**AN ORDINANCE AUTHORIZING THE ENLARGEMENT OF THE JOINT COUNTY INDUSTRIAL PARK BETWEEN DARLINGTON COUNTY, SOUTH CAROLINA AND FLORENCE COUNTY, SOUTH CAROLINA; AND OTHER MATTERS RELATED THERETO (PROJECT SCOUT).**

WHEREAS, pursuant to Article VIII, Section 13 of the South Carolina Constitution and Title 4, Section 1, Code of Laws of South Carolina, 1976, as amended (collectively, "*MCIP Act*"), Darlington County (the "*County*"), acting by and through its County Council ("*County Council*"), is authorized to jointly develop multicounty parks with counties having contiguous borders with the County and, in the County's discretion, include property within the boundaries of such multicounty parks; and

WHEREAS, under the authority provided in the MCIP Act, the County created a multicounty park ("*Park*") pursuant to that certain Agreement Governing the Darlington-Florence Industrial Park, effective April 21, 2016 (the "*Agreement*"); and

WHEREAS, Pit Stop Solar, LLC, a company formerly known to the County as Project Scout (the "*Company*") has obtained or will obtain control over certain land in Darlington County and is considering the establishment of a solar power generation facility on such land; and

WHEREAS, in connection therewith, the Company and the County desire to include certain property owned/controlled by or to be owned/controlled by the Company as more particularly described on Exhibit A attached hereto (the "*Property*") in the Park.

NOW, THEREFORE, BE IT ORDAINED BY THE DARLINGTON COUNTY COUNCIL:

**SECTION 1.** The County approves the inclusion of the Property within the Park.

**SECTION 2.** Pursuant to the MCIP Act and the terms of the Agreement, the expansion of the Park's boundaries is complete on adoption of this ordinance by County Council and the adoption of a resolution or ordinance by Florence County authorizing the expansion of the Park with a description of the additional property to be included in the Park.

**SECTION 3.** The provisions of this ordinance are hereby declared to be separable and if any section, phrase or provisions shall for any reason be declared by a court of competent jurisdiction to be invalid or unenforceable, such declaration shall not affect the validity of the remainder of the sections, phrases and provisions hereunder.

**SECTION 4.** All ordinances, resolutions, and parts thereof in conflict herewith are, to the extent of such conflict, hereby repealed. This ordinance shall take effect and be in full force from and after its passage by the County Council.

AMENDMENT TO AGREEMENT  
GOVERNING THE DARLINGTON-  
FLORENCE INDUSTRIAL PARK TO  
INCLUDE PROJECT SCOUT  
PROPERTIES

This Amendment to Agreement Governing the Darlington-Florence Industrial Park (the "*Amendment*") is made and entered into by and between Darlington County, South Carolina ("*Darlington County*") and Florence County, South Carolina ("*Florence County*"), each a body politic and corporate and political subdivision of the State of South Carolina (collectively the "*Counties*"), and is to be effective as of the 17<sup>th</sup> day of October, 2024.

WITNESSETH:

**WHEREAS**, Darlington County, acting by and through its County Council, and Florence County, acting by and through its County Council, are authorized pursuant to Article VIII, Section 13(D) of the Constitution of the State of South Carolina and Title 4, Chapter 1 of the Code of Laws of the State of South Carolina 1976, as amended, and specifically Section 4-1-170 thereof (collectively, the "*Park Act*"), to develop jointly an industrial or business park with other counties within the geographical boundaries of one or more member counties; and

**WHEREAS**, pursuant to the Park Act, Darlington County and Florence County entered into that certain Agreement Governing the Darlington-Florence Industrial Park dated as of April 21, 2016 (as amended, modified, and supplemented, collectively, the "*Park Agreement*"), whereby Darlington County and Florence County agreed to develop a joint county industrial or business park eligible to include property located in either Darlington County or Florence County (the "*Park*"); and

**WHEREAS**, Section 1.01 of the Park Agreement establishes the procedure for enlargement of the boundaries of the Park to include additional property; and

**WHEREAS**, Darlington County and Florence County, having determined that an enlargement of the boundaries of the Park to include therein certain property described in greater detail in Schedule 1 attached hereto (the "*Project Scout Properties*"), would promote economic development and thus provide additional employment and investment opportunities within said Counties, have agreed to enter into this Amendment of the Agreement Governing the Darlington-Florence Industrial Park to enlarge the boundaries of the Park by including therein the Properties that are located in Darlington County; and

**WHEREAS**, each of Darlington County and Florence County has authorized the execution and delivery of this Amendment by Darlington County Ordinance No. 24-12 and Florence County Resolution No. 19-2024/05

**NOW THEREFORE**, in consideration of the mutual agreement, representations and benefits contained in this Amendment and for other good and valuable consideration, the adequacy of which is hereby acknowledged, the parties hereby agree as follows:

1. Exhibit A-1 to the Park Agreement, which describes the boundaries of the Park property located in Darlington County, is hereby amended to include the Project Scout Properties, consisting of the parcels which are described on Schedule 1 hereto and made a part hereof by reference.

2. Except as expressly amended or modified herein, the remaining terms and conditions of the Park Agreement shall remain in full force and effect.

3. In the event that any clause or provisions of this Amendment shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not affect any of the remaining provisions hereof.

4. This Amendment may be executed in multiple counterparts, each of which shall be an original but all of which shall constitute but one and the same instrument.
