

COUNTY OF DARLINGTON

A RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT GOVERNING THE DARLINGTON-FLORENCE INDUSTRIAL PARK DATED APRIL 21, 2016, BY AND BETWEEN DARLINGTON COUNTY, SOUTH CAROLINA, AND FLORENCE COUNTY, SOUTH CAROLINA, TO EXPAND THE BOUNDARIES OF THE PARK TO INCLUDE CERTAIN REAL PROPERTY ALREADY SUBJECT TO EXISTING FEE IN LIEU OF TAX AGREEMENTS LOCATED IN DARLINGTON COUNTY AND PERTAINING TO B&K SOLAR, LLC, GEB SOLAR, LLC AND OTHER RELATED MATTERS.

WHEREAS, Florence County, South Carolina (“Florence”), and Darlington County, South Carolina (“Darlington”) (collectively, “Counties”), as authorized under Article VIII, Section 13(D) of the South Carolina Constitution and Section 4-1-170 of the Code of Laws of South Carolina, 1976, as amended (“Act”), have jointly developed the Darlington-Florence Industrial Park (“Park”);

WHEREAS, the Counties entered into an agreement entitled “Agreement Governing the Darlington-Florence Industrial Park” dated April 21, 2016 (“Park Agreement”), the provisions of which govern the operation of the Park;

WHEREAS, the Counties authorized the execution and delivery of an Amendment to that Park Agreement by Darlington County Council Ordinance No. 17-18 enacted on May 7, 2018 and Florence County Council Resolution No. 01-2018/2019 adopted on August 16, 2018, respectively, as effective as of August 16, 2018 including the boundaries of B&K Solar, LLC;

WHEREAS, the Counties authorized the execution and delivery of an Amendment to that Park Agreement by Darlington County Ordinance No. 19-13 enacted on July 1, 2019 and Florence County Council Resolution No. 14-2018/19 adopted on June 20, 2019 respectively, as effective as of July 1, 2019 including the boundaries of GEB Solar, LLC.

WHEREAS, it is now desired that the boundaries of the Park be enlarged to include certain additional property already subject to existing fee in lieu of tax agreements in Darlington related to B&K Solar, LLC and GEB Solar, LLC;

WHEREAS, pursuant to Section 1.01(a) of the Park Agreement, Florence or Darlington, through the adoption of a resolution or ordinance by its county council, may amend the Park Agreement by adopting a resolution or ordinance approving the expansion of the Park’s boundaries and the other County adopting a resolution approving the expansion of the Park’s boundaries;

NOW, THEREFORE, BE IT RESOLVED BY THE DARLINGTON COUNTY COUNCIL, DULY ASSEMBLED, AS FOLLOWS:

Section 1. Increase and Expansion of Park Boundaries. Exhibit A-2 to the Park Agreement is hereby and shall be amended to include the property located in Darlington described in the schedule attached to this Resolution. Accordingly, and for purposes of causing the Park Agreement to be amended as described herein, the Clerk to Darlington County Council is hereby directed to deliver to Florence a copy of this Resolution, including the schedule hereto.

Section 2. Savings Clause. If any portion of this Resolution is deemed unlawful,

unconstitutional or otherwise invalid, the validity and binding effect of the remaining portions are not affected.

Section 3. General Repealer. Any prior resolution, the terms of which are in conflict herewith, is, only to the extent of such conflict, repealed.

Section 4. Effectiveness. This Resolution shall be effective after its adoption by Darlington County Council.

WHEREAS, Florence County, acting by and through its County Council, and Darlington County, acting by and through its County Council, are authorized pursuant to Article VIII, Section 13(D) of the Constitution of the State of South Carolina and Title 4, Chapter 1 of the Code of Laws of the State of South Carolina 1976, as amended, and specifically Section 4-1-170 thereof (collectively, the "**Park Act**"), to develop jointly an industrial or business park with other counties within the geographical boundaries of one or more member counties; and

WHEREAS, pursuant to the Park Act, Florence County and Darlington County entered into that *Agreement Governing the Darlington-Florence Industrial Park dated as of April 21, 2016* (as amended, modified, and supplemented, collectively, the "**Park Agreement**", whereby Florence County and Darlington County agreed to develop a joint county industrial or business park eligible to include property located in either Florence County and Darlington County (the "**Park**"); and

WHEREAS, Section 1.01 of the Park Agreement establishes the procedure for enlargement of the boundaries of the Park to include additional property; and

WHEREAS, the Counties amended the Park Agreement by that certain Amendment effective August 16, 2018, between the Counties, in order to include certain property owned or leased by B&K Solar, LLC;

WHEREAS, the Counties amended the Park Agreement by that certain Amendment effective July 1, 2019, between the Counties; in order to include certain property owned or leased by GEB Solar, LLC.

WHEREAS, the Counties, having determined that an enlargement of the boundaries of the Park to include two additional parcels described in Schedule 1 attached hereto that are owned or leased by B&K Solar, LLC and one additional parcel described in Schedule 1 attached hereto that is owned or leased by GEB Solar, LLC would promote economic development and thus provide additional employment and investment opportunities within said Counties, have therefore agreed to enter into this Amendment to the *Agreement Governing the Darlington-Florence Industrial Park* between Florence and Darlington Counties to enlarge the boundaries of the Park by including therein such additional located in Darlington County; and

WHEREAS, pursuant to Article VIII, Section 13 of the South Carolina Constitution and Title 4, Section 1, Code of Laws of South Carolina, 1976, as amended (collectively, "*MCIP Act*"), Florence County (the "*County*"), acting by and through its County Council ("*County Council*"), is authorized to jointly develop multicounty parks with counties having contiguous borders with the County and, in the County's discretion, include property within the boundaries of such multicounty parks. Under the authority provided in the MCIP Act, the County has created a multicounty park with Darlington County ("*Park*");

WHEREAS, B&K Solar, LLC ("*B&K Solar*") and GEB Solar, LLC ("*GEB Solar*") have obtained certain land in Darlington County and are establishing economic development projects on such land (the "*Projects*"); and

WHEREAS, a multi-county industrial park was created pursuant to that certain *Agreement Governing the Darlington-Florence Industrial Park dated as of April 21, 2016*, and any amendment thereto (the "*Agreement*") between the County and Darlington County, as amended by those certain Amendments entered into as of August 18, 2018 for B&K Solar and July 1, 2019 for GEB Solar, by and between the County and Darlington County to include certain property owned by B&K Solar and GEB Solar;

WHEREAS, in connection therewith, the County and Darlington County desire to include two additional parcels to be owned or to be leased by B&K Solar, and one additional parcel to be owned or to be leased by GEB Solar as more particularly described on Exhibit A-2 attached hereto (the "*Property*") in the Agreement;

WHEREAS, the County desires to expand the boundaries of the Park and amend the Agreement to include the Projects by an amendment to the Agreement in substantially the same form as set forth on Exhibit B attached hereto (the "*Amendment*").

NOW, THEREFORE, BE IT RESOLVED BY THE FLORENCE COUNTY COUNCIL DULY ASSEMBLED as follows:

SECTION 1. The enlargement of the boundaries of the Park for inclusion of three additional parcels to the previously approved Projects, as set forth in the Amendment is hereby authorized and approved. The provisions, terms, and conditions of the Amendment presented to this meeting and filed with the Clerk to the Council are hereby approved, and all of the provisions, terms, and conditions thereof are hereby incorporated herein by reference as if the Amendment were set out in this resolution in its entirety. The Chairman of the Council is hereby authorized, empowered, and directed to execute and deliver the Amendment in the name and on behalf of the County; the Clerk to the Council is hereby authorized, empowered and directed to deliver the Amendment to Darlington County. The Amendment is to be in substantially the form now before this meeting and hereby approved, or with such changes therein as shall not materially adversely affect the rights of the County thereunder and as shall be approved by the officials of the County executing the same, their execution thereof to constitute conclusive evidence of their approval


of any and all changes or revisions therein from the form of Amendment now before this meeting

SECTION 2. The Resolution shall take effect and be in full force from and after its passage by the County Council.




